If you make such a request, you are responsible for the fees and costs associated with furnishing you the documents specified in the request. The clerk may require a deposit to cover the estimated costs of furnishing you with the requested notice.**

**You are notified that, if you are a relative of the proposed ward as defined in Sec. 1051.103(a)(2) or (a)(4), and if a guardianship is created for the proposed ward, you must file your election in writing in order to receive notice about the health and residence of the proposed ward should a guardianship be created under Sec. 1151.056, Estates Code.**
