# Deadlines By County

## Mandatory Criminal E-Filing

### Court of Criminal Appeals Order

E-filing will be mandatory in criminal cases in the district courts, statutory county courts and constitutional county courts according to the following implementation schedule based upon the counties' 2010 Federal Census population :

- a. Courts in counties with a population of 500,000 or more - July 1, 2017
- b. Courts in counties with a population of 200,000 to 499,999 - January 1, 2018
- c. Courts in counties with a population of 100,000 to 199,999 - July 1, 2018
- d. Courts in counties with a population of 50,000 to 99,999 - January 1, 2019
- e. Courts in counties with a population of 20,000 to 49,999 - July 1, 2019
- f. Courts in counties with a population less than 20,000 - January 1, 2020

*NOTE: Courts may elect to mandate electronic filing before the date prescribed by the Court of Criminal Appeals. Please consult [www.eFileTexas.gov](http://www.eFileTexas.gov) for more information.*
