Lone Star Legal Aid's Military and Veterans Unit (MVU) provides free civil (non-criminal) legal services to low-income military veterans, their dependents, and surviving spouses. If you are a veteran, dependent, or surviving spouse who needs legal assistance, apply today for help fighting your legal battles.

Who can get help:

- You, if you have served in the military, are married to a veteran or are the surviving spouse of a veteran, or are the child or other dependent of a veteran and currently depend on the veteran for support.
- Your legal problem is a civil (non-criminal) issue.
- You live within LSLA's service area (see list of counties on the back).
- You are low-income and meet income qualifications.

We may ask you to give us a copy of the veteran's DD-214, a military or dependent ID card, or a VA Healthcare ID card to verify veteran connection or status. If you do not have a copy of the veteran's DD-214, we can help you get one for free.
