As contestants I, the undersigned, recognize that all equestrian related activities are extremely dangerous, that accidents involving horses are frequent, that the condition of the land is often hazardous and that the arena footing and facilities can be variable. In light of this knowledge, I undertake full responsibility for all harm that comes to us individually and as a team, as well as our stock and associates for participation in the event and use of the facilities. With full knowledge, I the undersigned release and indemnify Chambers County and the Chambers County Youth Project Show, as well as their contractors, employees and volunteers from any and all responsibility for accidents, injuries, damage and claims. Signing this release affirms that I have adequate medical and liability insurance/protection, including self-insurance, and that Chambers County and the Chambers County Youth Project Show will assume no responsibility for horse, rider or personal property. Losses occasioned by the injury or death of rider, spectator or horse is agreed to be covered by the undersigned and it is further agreed that the undersigned, successors, assigns, heirs, representatives, dependents or guests shall have no right or action against Chambers County, the Chambers County Youth Project Show or any of their insurance carriers. If damage is caused by or to the undersigned, their horse or horses, the undersigned take full responsibilities for damages to persons, property or other horses and agrees to indemnify Chambers County and the Chambers County youth Project Show for such damages.
