**REQUEST FOR MANDATORY DRIVING SAFETY COURSE**

Now comes the above named Defendant in this matter and requests this case be deferred for ninety (90) days to allow Defendant to complete a Driving Safety Course (DSC), under article 45.0511 CCP, approved by the Texas Education Agency. After being by me duly sworn, Defendant on oath deposes and says:

- I hereby waive my right to a jury trial and enter a plea of  GUILTY or  NO CONTEST to the charge of \_\_\_\_\_;
- I have a valid Texas Driver’s License or Permit (not a commercial driver’s license);
- I am a member, or the spouse or dependent child of a member, of the United States Military forces serving on active duty; Division of Armed Services: \_\_\_\_\_;
- I am not charged with speeding 25 mph or more over the posted speed limit;
- I am not charged with speeding more than 95 mph;
- I am not in the process of taking a Driving Safety Course for a different traffic offense;
- I have not taken DSC within the past 12 months to obtain dismissal of a traffic offense;
- I must provide my driving record, from Texas Dept. of Public Safety, to the court;
- I must provide proof of financial responsibility (automobile liability insurance), with my name listed as a covered person, to the court.

I understand this offense will be dismissed upon successful completion of DSC, by the due date **ORDERED** by the Court, upon approval of this request and upon me providing the following to the court:

- **Pay \$140.00 (for offenses after 01.01.2020)**
- **Provide proof of insurance to the court**
- **Present the Certificate of Completion of an approved Driving Safety Course; and**
- **Present a certified copy of my driving record (Type 3A) from the Texas Dept. of Public Safety at: <https://www.dps.texas.gov> (search Driver License & ID > Online Services > Driver Record)**

Failure to take the course, give the Court my certificate of completion, or any other required items, by the due date ordered by the Court, my appearance will be required at a hearing to show cause why proof, or other required items, were not timely submitted. At that time, the Court may enter a judgment of guilt, assess a fine, or give an extension for compliance. If I fail to appear at the hearing, the Court will enter a judgment of guilt and the offense will appear as a conviction on my driving record, I will be assessed the balance of the fine, along with additional collection fees and a warrant may be issued for my arrest.
