**PETITION FOR CREATION OF CHAMBERS COUNTY  
DRAINAGE DISTRICT NUMBER ONE**

TO THE HONORABLE CHAMBERS COUNTY COMMISSIONERS COURT:

Petitioner, *Marcia Hodge*, files this petition for creation of Chambers County Drainage District Number One, and respectfully shows in support:


1. At all times mentioned in this petition, petitioner is and was an individual resident and taxpayer of Chambers County, Texas, residing at *9059 Tumblewood Drive, Beach City, TX 77523*.
2. Petitioner seeks the creation of a drainage district in Chambers County, to be known as the Chambers County Drainage District Number One.
3. Creation of the Chambers County Drainage District Number One is a necessity, in that Chambers County, and in particular the land described in this petition, are prone to flooding and draining difficulties during heavy weather events.
4. Creation of the Chambers County Drainage District Number One is of public utility, in that a drainage district could help alleviate multiple flooding and drainage problem areas, and prevent issues associated with those events, such as property damage, loss of life, and disease.
5. Creation of the Chambers County Drainage District Number One is feasible, in that the area hosts many waterways and drainage areas which, with proper infrastructure, can improve the situation considerably.

6. The proposed boundaries of Chambers County Drainage District Number One are as follows: *All Land of Chambers County, Save and Except any and all land current within Trinity Bay Conservation District.*
7. This petition is signed by *Chambers County* resident freehold taxpayers, as required by Section 56.014(a) of the Texas Water Code. A check in the amount of \$ 287.00 is also attached, as required by Section 56.015(a) of the Texas Water Code.







Therefore, petitioner respectfully requests that the Chambers County commissioner's court:




1. Schedule a hearing on the petition at a regular or special meeting of the commissioner's court within the time required by Section 56.016 of the Texas Water Code;
2. After a hearing on the petition, enter and record findings that drainage of the proposed district is feasible, practicable, and needed, and would be conducive to public health or would be a public benefit or a public utility;
3. Appoint a competent civil engineer to develop a preliminary report on potential improvements in the proposed district as permitted by Sections 56.020 et seq. of the Texas Water Code; and
4. Authorize the creation of Chambers County Drainage District Number One as described in this petition.
