1.1 BACKGROUND:

It is home to a diverse economy and population with a great deal of rural agricultural activity, scaling up to densely populated residential areas and highly concentrated, high-risk industrial plants. The population is growing at a fairly significant rate and is projected to accelerate its growth over the next decade.

Cart Pathway replacement size is approximately 1500 ft.

- Replacing approximately 1500 ft. of cart path
- Need to be formed with 1x4 lumber and 3/8 rebar
- Expansion joints need to be redwood with rebar 20 ft. apart
- All concrete that needs to be cut out will be done by bidder
- New Concrete will be tied into old concrete with rebar
- County will remove old concrete
- If course is too wet, NO equipment will be allowed on course
- Georgia Buggies will be acceptable to deliver concrete
