RESOLUTION (NO. 2022-02)

A RESOLUTION DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO THE OFFICE FOR WHICH THEY FILED, IN THE LA PORTE INDEPENDENT SCHOOL DISTRICT GENERAL ELECTION SCHEDULED FOR MAY 7, 2022; PROVIDING FOR POSTING OF A COPY OF THIS RESOLUTION ON ELECTION DAY AT EACH POLLING PLACE THAT WOULD HAVE BEEN USED IN THE ELECTION; PROVIDING THAT A CERTIFICATE OF ELECTION SHALL BE ISSUED TO EACH CANDIDATE IN THE SAME MANNER AS PROVIDED FOR A CANDIDATE ELECTED AT THE ELECTION; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; AND PROVIDING AN EFFECTIVE DATE HEREOF.

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE LA PORTE INDEPENDENT SCHOOL DISTRICT:

1. The Board of Trustees of the La Porte Independent School District has received a certification of unopposed status from the Administrative Assistant to the Board of Trustees, dated March 1, 2022, a copy of which is attached to this Resolution as Exhibit "A", and incorporated by reference herein.
2. The Board of Trustees of the La Porte Independent School District hereby declares each unopposed candidate, as listed in the Board Secretary's certificate attached hereto, elected to the office listed by the name of each candidate, and cancels the general election scheduled to take place on May 7, 2022.
3. The Board Secretary shall post a copy of this Resolution on election day at each polling place that would have been used in the election.
4. A certificate of election shall be issued to each candidate in the same manner as provided for a candidate elected at the election.
5. The Board of Trustees officially finds, determines, recites, and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the Board of Trustees was posted at a place convenient to the public at the Administration Building and for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government

Code; and that this meeting has been open to the public as required by law at all times during which this Resolution and the subject matter thereof has been discussed, considered and formally acted upon. The Board of Trustees further ratifies, approves and confirms such written notice and the contents and posting thereof.

6. This Resolution shall be effective from and after its passage and adoption.


