2. **Terms of Sale.** Cash.

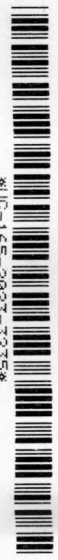


