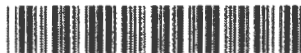
4. Terms of Sale. The sale will be conducted as a public auction to the highest bidder for cash. 5. Obligations Secured. The Deed of Trust executed by BRIAN A STANFORD, provides that it secures the payment of the indebtedness in the original principal amount of \$148,117.00, and obligations therein described including but not limited to (a) the promissory note; and (b) all renewals and extensions of the note.
