You are notified that you have the right under Texas Estates Code Sec. 1051.252 to file with the clerk a written request that you may be notified of any or all specifically designated motions, applications, or pleadings filed by any person, or by a person specifically designated in your request, relating to the application for the guardianship that has been filed or relating to any subsequent guardianship proceeding involving the ward after the guardianship is created, if any. If you make such a request, you are responsible for the fees and costs associated with furnishing you the documents specified in the request. The clerk may require a deposit to cover the estimated costs of furnishing you with the requested notice.

You are notified that, if you are a relative of the proposed ward as defined in Sec. 1051.103(a)(2) or (a)(4), and if a guardianship is created for the proposed ward, you must file your election in writing in order to receive notice about the health and residence of the proposed ward should a guardianship be created under Sec. 1151.056, Estates Code.
